

Margaret River On Tour Terms & Conditions

1. These Terms and Conditions apply to the Margaret River On Tour prize package promotion (the “Competition”).
2. You (the “Entrant”) will be governed by these Terms and Conditions.
3. The provider of the prize package is Margaret River Busselton Tourism Association (MRBTA) (the “Promoter”) (ABN 62 934 317 700).
4. Entry to the Competition is via the booking form on www.margaretriverontour.com. You must be an individual and not a company or organisation.
5. You must be age 18 years old to submit a valid Entry.
6. You must live in Singapore for your entry to be valid.
7. Employees of the Promoter, any person associated with the Competition, and any organisation or individual associated with the provision of the prize(s), are not eligible to enter.
8. Each Entry must be entered in accordance with these Terms and Conditions. By entering the Competition, You agree to be bound by these Terms and Conditions. The Promoter may in their discretion refuse to award any prize to any Entrant who fails to comply with these Terms and Conditions. All relevant instructions on the Promoter’s website form part of these Terms and Conditions.

Any entry received after the expiry of the Competition Period will be deemed invalid. No responsibility is accepted for late, lost, delayed or misdirected entries.
